**GYM RULES & POLICIES**

**Payments:** All payments are due by the **15<sup>th</sup> of the previous month**. See **payment options** (ex: March payment is due by Feb. 15). Place your payment in an envelope with your child's name and class day and time on the outside of the envelope and place in the payment box . There will be a \$25 fee on any returned check. **Fees are non-refundable. A late fee of \$20 will be added to your account for payments not received by due date. You are responsible for payment regardless of attendance**

**Annual Registration fee:** The registration fee is charged on an annual basis when registering and is due on August of each year. Registration fee is **non refundable**. If a student is withdrawn and then re- enrolls at a later date the registration fee is then charged again depending on new enrollment date.

**Uniforms:** Girls in all gymnastics classes should wear ONE PIECE leotards. Bare feet are recommended. No jeans, shorts, or pants with belts or buckles or zippers. Hair must be tied away from the face. No jewelry is allowed in class. Boys may wear athletic shorts & t-shirts. Middle/High school cheer classes need shorts, cami tops, tshirts and tennis shoes.

**Withdrawals:** **Parent must notify A+ Gymnastics in writing of withdrawal of student 30 days prior to withdrawal date. You are responsible for all fees incurred up to the withdrawal date.**

**Make – ups;** **No credits or refunds will be given for classes not attended.** Students may make – up a maximum of 1 missed lessons per month providing that there is space available. Make –up days and times must be cleared with the front office **one week** prior to requested time.

**Valuables:** Valuable items should not be brought to the gym. A +Gymnastics & Cheer Academy, LLC will not be responsible for lost or stolen items.

**Holidays:** Schedules will be posted at the beginning of each month. Any holidays, class changes, or closings will be posted at that time.

**Classes:** Classes will start on time. Do not leave students unsupervised prior to the start of their class. Students must be picked up on time. A late fee will be charged to you if your child is not picked up on time.

**Visitors:** Visitors and parents are asked to sit in the waiting area. Any interruptions could result in serious injury.
